

Bosch & O'Brien Glass Industries Racing Simulator Promotion

Terms and Conditions

1. The Promoter is Robert Bosch (Australia) Pty Ltd, 1555 Centre Road, Clayton Victoria 3168. Phone: 1300 30 70 37 ABN: 48 004 315 628.
2. Information on how to enter form part of these Conditions of Entry. Entry into this Promotion is deemed to be an acceptance of all Conditions of Entry.
3. The Promotion commences on 16th October 2021 and concludes 24th December 2021 (Promotional Period).
4. Entry is open to all customers who purchase Bosch Wiper Blades from distributor O'Brien Glass Industries Limited (ABN 74 000 022 275). Employees and their immediate families of the Promoter and associated agencies, suppliers, retailers or companies associated with this Promotion are ineligible to enter.
5. For your chance to win and receive one automatic entry into the draw, entrants must:

Purchase Bosch Wiper Blades from distributor O'Brien Glass Industries Limited (ABN 74 000 022 275) between 16th October 2021 and 24th December 2021 to receive one automatic entry into the draw.
